**PLEASE INSTRUCT THE ISSUING BANK TO ADVISE SCOTIABANK TO NOTIFY ABRAMS & KROCHAK JUST AS SOON AS YOUR PAYMENT ARRIVES IN CANADA.**

Should you follow this route, please be advised that any personal information you supply is kept in the strictest confidence and, for your own protection, no information is held on any of our servers. Furthermore, our online credit card payment facility is secured by [Paymentech](#) and cannot be viewed by any third party. All transactions are processed directly with our banking institutions by [Paymentech](#), the industry standard, at the highest available current encrypted security level.

If you are unable to pay by credit card or VISA debit card online, you **MUST** photocopy or scan the front and back of your MasterCard, VISA, VISA Debit or American Express and send us the image, via facsimile, or as an attachment to an e-mail. We also require from you a signed authorization with the following wording:
